ANNOUNCEMENT

The Club MSC Großheubach will promote the 1st round of the FIM Women's Trial World Championship on behalf of the German Federation (DMSB). The event will be held in accordance with the Sporting Code of the FIM together with relevant Appendices, these Supplementary Regulations and any Final Instructions, approved by the Jury. The event has to respect the FIM Environmental Code.

1. ENTRIES

Entries must be made on the official entry form and sent to the FIM Secretariat. All entries must be received by 6 August 2011.

All riders must have their entry endorsed by their own FMN.

2. TECHNICAL CONTROL AND REGISTRATION

The administrative and technical controls will take place on Friday 19 August between 9:30 and 11:30.

A second technical control shall take place on Sunday 21 August, 10 min. before the start of each rider.

Each machine must be road legal for the Country in which it is registered and comply with all requirements of the FIM Sporting Code including those under Art. 054.8.1. Parts will be marked in accordance with Art. 054.8.4. Sound level control will be carried out in accordance with Art. 054.8.3.

At administration control, all riders must submit their FIM Women's World Championship licence, valid for the event.

At the technical control, all riders must submit the administrative documents of their motorcycles and a helmet, according to the FIM standards.

3. BIBS

The riders must wear the bib given by the CTR.

4. STARTING ORDER

The starting order will be decided according to Art. 054.7.7.

Last starter will depart at 11.00 on 21 August

5. COURSE

The initial starts will be given every minute.

The course will consist of two laps of 15 sections. Length of the course: 5 km

The overall time allowance for each rider shall be 5h00

6. PADDOCK/PRACTICE

The paddock will be opened to all riders from Thursday before the event at 13.00.

Any rider found practicing outside the areas set aside by the organisers may not be allowed to start.

The practice area must be open to all riders one day before the event.

7. HEADQUARTERS AND JURY MEETINGS

The Headquarters for the event will be at the starting area and Jury Meeting will be held at the Office at the starting area.

The meeting with the organisers and the Jury President and/or the CTR Representative will be held the Thursday before the event at 18.00.

The first Jury meeting will be held on Saturday at 16.45.

8. AWARDS

Awards will be presented to the first 3 placed riders in the final classification.

9. PRIZE GIVING CEREMONY

The prize giving ceremony will take place each day in the start area within 15 minutes of the final classified rider of the day arriving at the finish.
